- 5.0 Audit and approval of monthly expenditures T. Zignego noted we will be reimbursed \$300 for the item listed in Training/Travel Exp. N. Reichoff noted the Roger Dickert memorial has received almost \$2000 to date. H. Pringle made a motion to approve. J. Gasser made a second. Motion carried.
- 6.0 Directors Report T. Zignego reports circulation is up 4%. Nick Elhart will be transitioning into his new position in September and we are advertising for a circulation aide to replace him.
 The library has a new team of 12 volunteers, known as the Dust Busters, helping with dusting

- Shelves. This will help alleviate some cleaning costs.
- 6.0 Continued Hearing Loop has been installed in the community room and the hideout.33 photos were entered in the photo contest and September is Library Card sign up month.
- 7.0 The board meet with Ron Bittner from DPW and Sara Ehrhardt from Seasonal Services and walked outside to look at the bid being proposed. Ron and Sara will have to work together and come up with a plan to present to the board for further review for parking lot run off. Board decided to table any discussion until next month in regards to both the swale area and edging.
- 8.0 Finance Committee report J. Gasser made a motion to establish the "Mukwonago Community Library Capital Endowment Fund". H. Pringle made a second. Motion was amended to have Northern Trust as the fund advisor. Motion passed as amended. The Village has received \$181,742.02 from the Gollmar Fund to date. This will be put into a new WCCF Capital Endowment Fund.
- 9.0 Policy committee report
 - a. Circulation Policy A motion was made by D. Whalen to adopt the revised circulation policy. N. Reichoff made a second. Motion carried.
 - b. Theft/Privacy Policy policy committee is working on stand alone policies and will present at the next meeting.
 - c. Meeting Room Policy H. Pringle, T. Zignego and staff will work on updating the policy and present at the next meeting. H. Pringle also discussed an orientation session for new board members and will work on the for the next meeting as well.
